- The Tournament Committee reserves the right to cancel any event due to insufficient entries.
- Teams shall have preliminary round robin groups of 3, or 4 followed by single knockout.
- Team matches are played by Corbillon Cup System (AvX, BvY, dbl. AvY, BvX), to best of 5 individual matches (3-0, 3-1, 3-2).

#### Rules

- Current ITTF Laws of Table Tennis will be in effect.
- All rackets must be one side black and one side red with ITTF approved coverings.
- Tie-breaks in round-robins will be decided by score of team matches, matches, games, points, only of those players involved in the tie.
- Street clothes, tracksuit or any part thereof shall not be worn during match except by special permission of the Referee (see ITTF regulations).
  - Shorts/Skirts and short sleeve or sleeveless playing shirt MUST be worn during match. Colour of playing shirt should not be white or bright yellow and playing shoes must be non-marking.
- Events with fewer than 4 entries may be cancelled or combined with another event at the discretion of the Tournament Committee.
- Unpaid entries at the time of the Draw will NOT be in included in the tournament.

#### **Umpiring**

Players will be required to umpire their own matches. Umpires provided for S-F & finals.
